FAIRBANKS MEMORIAL HOSPITAL (FMH) EMERGENCY ROOM

For Patients Who Reside in the Interior Alaska Service Unit (IASU) (If you reside outside the IASU, please contact your Service Area Contract Health Office)

Effective JULY 1, 2005, TCC no longer pays for Emergency Room visits to the Fairbanks Memorial Hospital Emergency Room (FMH-ER) *except* in the following cases:

- 1. Pregnant Women as instructed by provider during prenatal visits.
- 2. Infants under the age of one year and for Elders with onset of a sudden condition.
- 3. Treatment for a medical condition for which immediate medical attention is necessary to prevent death or serious impairment of the health of an individual.
- 4. Referrals made by a CAIHC Physician or by the after-hours Providence Hospital Triage Nurse who received approval from a CAIHC physician.
- 5. Needs to be a resident of the TCC Region and eligible for Contract Health Services. *Patients will be held financially responsible for all FMH-ER visits that do not fit these criteria.*
